On behalf of Sage Telecom Communications, LLC, and pursuant to Staff's Information Request No.2, the company provides the following information to supplement its application filed in the above-referenced docket:

Q2-1: Please provide the South Dakota Sales Tax Number for Sage Telecom Communications, LLC pursuant to 20:10:24:02.17 and 20:10:32:03.24.

Response: *Sage Telecom Communications, LLC has been issued South Dakota Sales Tax License Number 1027-0382-ST.*

Q2-2: Will you be filing a revision to your Interstate Tariff with the PUC updating the Name that is on the Intrastate Tariff from Sage Telecom, Inc. to Sage Telecom Communications, LLC?

Response: *Yes, a revision to the Interstate Tariff will be filed updating the name change, and that filing will be made after the Commission's grant of the amended COA but before provision of service to South Dakota customers.*

Q3-3: I see Sage Telecom, Inc. has a \$25,000 bond with the PUC currently. Will that be transferred to the Sage Telecom Communications, LLC name? If so, please provide documentation for the transferring the bond.
