Citizens Telecommunications Company of Minnesota, LLC, hereby provides a copy of its Annual Lifeline Eligible Telecommunications Carrier Certification Form in compliance with 47 CFR 54.416 as adopted by the Federal Communications Commission (FCC) in its Lifeline Reform Order, FCC 12-11, released February 6, 2012.

Section 54.416(b) requires eligible telecommunication carriers (ETCs) to annually provide the results of their recertification efforts performed pursuant to Section 54.410 (f) to the FCC and the Universal Service Administrative Company (USAC). ETCs are also required to provide the results of their recertification efforts to state commissions for subscribers residing in those states where the state designated the ETC.

The attached certification form includes counts of Iowa, Minnesota, and North Dakota and South Dakota customers. Iowa customers are included because Study Area Code 367123 includes, in addition to Minnesota customers, Iowa customers served from the Adams, Bigelow, Kiester, LeRoy, and Lyle Minnesota exchanges. Also, North Dakota and South Dakota customers are included because Study Area Code 361123 includes not only Minnesota customers but also the North Dakota and South Dakota customers served from the Oslo and Jasper Minnesota exchanges, respectively. There were no South Dakota Lifeline customers.
