SECTION 63.71 APPLICATION

New Global Telecom, Inc. ("NGT") hereby seeks authorization, pursuant to Section 214(a) of the Communications Act of 1934, as amended (the "Act"), 47 U.S.C. § 214(a), and Section 63.71 of the rules of the Federal Communications Commission ("FCC" or "Commission"), 47 C.F.R. § 63.71, to discontinue: (1) its offering and provision of voice over Internet protocol ("VoIP") services and associated features such as operator services, directory assistance, messaging, conferencing, and faxing capabilities; and (2) its wholesale VoIP platform (collectively, the "VoIP services"). NGT's VoIP services are no longer consistent with the business plans of NGT's parent company, Comcast Corporation ("Comcast"), and will not remain commercially viable. Comcast and NGT have decided, therefore, to discontinue the VoIP services in a controlled and coordinated manner.

Specifically, NGT intends to stop offering the VoIP services to the public and providing these services to its limited number of remaining customers on or after December 31, 2015. The proposed discontinuance will not result in material harm to these customers, as they may obtain alternative services from a variety of other providers, including traditional wireline, facilities-based VoIP, and non-facilities-based VoIP providers.

NGT provides the following information pursuant to Section 63.71 of the Commission's rules:

1. Name and Address of Carrier: New Global Telecom, Inc., 143 Union Boulevard, Suite 400, Lakewood, Colorado 80228.
2. Date of Planned Service Discontinuance, Reduction, or Impairment: NGT plans to discontinue its provision of the VoIP services on or after December 31, 2015. NGT understands that this Application will be granted automatically on the 31st day after public notice of its filing, unless the Commission notifies NGT to the contrary.
3. Points of Geographic Areas of Service Affected: NGT proposes to discontinue its offering and provision of the VoIP services in each of the fifty United States and the District of Columbia.
4. Brief Description of Type of Service Affected: NGT's VoIP services and associated features enable inbound and outbound voice calling, as well as operator services, directory assistance, messaging, conferencing, and faxing capabilities. NGT also seeks authority to discontinue its wholesale VoIP platform, which it currently provides to only one customer. These services are being discontinued because they are no longer consistent with Comcast's business plans and will not remain commercially viable.
5. Brief Description of the Dates and Methods of Notice to All Affected Customers: In accordance with Section 63.71(a), on October 30, 2015, NGT provided written notice, by first class mail, to all affected customers. A sample copy of the notice provided to customers is attached hereto as Attachment A. In addition to this formal notification, NGT previously contacted each of its customers to advise them of NGT's plan to discontinue the VoIP services.

6. Whether the Carrier is Considered Dominant or Non-Dominant with Respect to the Service to be Discontinued, Reduced, or Impaired: NGT is considered non-dominant with respect to the affected services.

In accordance with Section 63.71 of the Commission's Rules, a copy of this Application is being mailed to the Special Assistant for Telecommunications for the Secretary of Defense and to the public utility commission and the Governor of each state in which the discontinuance of service is proposed.

The public convenience and necessity will not be adversely affected by the discontinuance of the VoIP services. All customers that will be affected have been given notice affording them ample time to acquire one of the many substitute services that are readily available to them. NGT, therefore, respectfully requests Commission approval of this Section 63.71 Application. Please direct any questions regarding this Application to the undersigned.

We are writing to remind you that New Global Telecom, Inc. ("NGT"), a Comcast company, intends to discontinue its offering and provision of interconnected voice over Internet protocol ("VoIP") services and associated features as soon as December 31, 2015. NGT's VoIP services enable inbound and outbound voice calling, as well as operator services, directory assistance, messaging, conferencing, and faxing capabilities. NGT's wholesale VoIP platform also will be discontinued. This discontinuance will affect service in each of the fifty United States and the District of Columbia.

Please note that you are responsible for making the necessary arrangements to transition to one of the many alternate service providers that are available in your area. NGT will continue to provide you with reasonable support and assistance during your transition in order to minimize the potential for service disruptions. You also may continue to place orders for additional services, at the prices specified in your agreement, on a month-to-month basis, until they are discontinued.

NGT has notified the Federal Communications Commission ("FCC") about its plan to discontinue these VoIP services and features. The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the FCC releases public notice of the proposed discontinuance. You may file your comments electronically through the FCC's Electronic Comment Filing System using the docket number established in the FCC's public notice for this proceeding, or you may address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, 445 12th Street, SW, Washington, DC 20554, and include in your comments a reference to the § 63.71 Application of New Global Telecom, Inc. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.
