Oct. 16, 2014 with a 7 p.m. ago and you can still see there is shrapnel in my chest," Meyer said. But without that certificate, the VA just can't recognize the war injury.

It wasn't as if Meyer didn't try to obtain the certificate. He said he asked for it when he was overseas serving in Vietnam. He approached the VA a few years ago and was told then they would work on his behalf and obtain the certificate. He even sent in letters himself. No responses. He was finally told his best chance of obtaining the certificate was to get a Senator involved, so Meyer turned to Heitkamp, who was born in Mantador, North Dakota. "Almost immediately I

found out she would go for it," he said.

It only took a few months and much of that was waiting for a date to actually meet for the certificate and medal presentation. In addition to the certificate Meyer received the Army Good Conduct Medal with two Bronze Service Stars, Meritorious Unit Commendation, National Defense Service Medal and the Gallantry Cross from Vietnam. He had previously earned these medals, but his military record did not correctly indicate his eligibility for them.

We must never forget what makes us strong and who has sacrificed to keep us safe. Honoring American heroes like Sgt. Richard Meyer, who fought for the freedom of future generations, is an intrinsic part of making sure we continue to thank those who served. That's why I'm deeply committed to making sure that our veterans are never forgotten," Heitkamp said.

Meyer clearly remembers the night when the mortar round hit. He was a private first class at the time and served as a helicopter mechanic. His job was to recover downed helicopters and he was in the battle zone for only one month before being injured. Meyer said he thought he was going to die since he was in shock and didn't know how badly he was injured. Medics in camp came on the run and medivacked the wounded out by helicopter.

The medic told Meyer he wasn't too badly injured and he was able to walk to the helicopter. He said that is when he figured he would survive the wounds. He first was transferred to a first aid center and then to a military hospital in Japan. Mever was in that hospital for about 45 days as he healed from his injuries. Meyer did return to action after he healed.

The Meyer family has a grand tradition of serving during wartime. His uncle, Peter Meyer, was in World War I, while his father, Nick, was in World War II. A cousin, Donald, served in Korea, Meyer served in Vietnam and his daughter Joan's oldest son, Nathan, served in the Persian Gulf.

Meyer and his wife, Joan, have six adult children including Bradley Meyer, Fargo, Pamela (Chris) Wagner, Grand Forks, who are both retired from the U.S. Air Force, Bryan (Kim) Meyer, Gardner, Wendy (Dan) Wang, Alexandria, Minnesota, Jennifer (Jason) Fuchs, Jenkins, Minnesota, and Matthew Meyer and his fiance, Rachel, Bellevue, Michigan. He also has 13 grandchildren and two great-grandchildren.
