**SECTION 63.71 APPLICATION OF AT&T**

AT&T Services, Inc. on behalf of its affiliates AT&T Corp., AT&T Communications of Indiana, LLC, AT&T Communications of New York, Inc., AT&T Communications of Texas, LLC, AT&T Communications of Virginia, LLC, and Alascom, Inc. d/b/a AT&T Alaska, collectively referred to herein as "AT&T", applies for authority under Section 214(a) of the Communications Act, as amended ("the Act"), 47 U.S.C. § 214, and Section 63.71 of the Federal Communications Commission's ("Commission") rules, 47 C.F.R. §63.71, to discontinue residential and business calling card services. This discontinuance will not impact prepaid calling cards and pre-paid minutes provided by AT&T.

As required by Section 63.71(a) and (b) of the Commission's rules, AT&T provides the following information:

**Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (b)(2)):**

AT&T plans to plans to discontinue this service on or after October 1, 2016 subject to Commission authorization of the discontinuance pursuant to 47 C.F.R. § 63.71(c).

**Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), b(2)):**

AT&T will discontinue this service in all 50 states, including the District of Columbia, and the following U.S. territories, Puerto Rico, and the U.S. Virgin Islands.

**Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(3), b(2)):**

AT&T plans to discontinue residential and business calling card services including AT&T CIID/891 Card, AT&T Military Calling Card, AT&T Global Calling Card, and the Commercial Calling Card. These calling card services allows users to place intrastate, interstate and/or international calls by dialing a company-provided toll-free access code or number.

The public convenience and necessity will not be impaired by this service discontinuance because calling card usage has been declining for several years. This is due to the market growth of other communication methods, including mobile phones,

email, social media streams and voice over IP. As mentioned above, this discontinuance will not impact prepaid calling cards and prepaid minutes provided by AT&T.

**Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71(b)(3)):**

AT&T sent notice to the majority of its residential customers that it has a direct billing relationship in their June 2016 bill.<sup>1</sup> On July 23, 2016, AT&T mailed its customer notice to the remaining residential customers.<sup>2</sup> AT&T sent notice to its business customers that it has a direct billing relationship with in their July 2016 bill.<sup>3</sup> AT&T also has customers using these services that it does not have a direct billing relationship with in Independent Telephone Company (ICO) territories. AT&T arranged for the ICOs to send notice to the residential and business customers in those territories in their July 2016 bills. In addition, copies of the customer notices are also posted on AT&T's website and AT&T's operators will refer customers to a recording of the notice upon receiving an inquiry concerning these calling card services.<sup>4</sup>

Copies of this Application are being sent, first class U.S. Mail, to the public utilities commissions and governors of the affected states and also to the Special Assistant for Telecommunications to the Secretary of Defense, as required by 63.71(a) of the Commission's rules.

**Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):**

AT&T is considered non-dominant with respect to the services to be discontinued.
