Re: Rule 54.312(c)(4) Notice; Connect America Fund, WC Docket No. 10-90

Dear Ms. Van Gerpen:

On September 13, 2016, pursuant to Federal Communications Commission (FCC) rules, <sup>1</sup> CenturyLink, on behalf of its incumbent local exchange carriers receiving 2013 Connect America Fund Phase I incremental support (CAF I Round 2 support), provided notice to the FCC of its intent to use that support for broadband deployment in census blocks that it has not previously identified.

When CenturyLink initially accepted CAF I Round 2 support in August 2013, it provided a list of census blocks in South Dakota where it anticipated using that support to deploy broadband to unserved and underserved locations.<sup>2</sup> That list was subsequently updated on February 24, 2015 by letter to the Commission to reflect the results of the FCC challenge process. Since that time, CenturyLink has modified its broadband deployment plans under the CAF I Round 2 program and is hereby providing the attached list of 52 additional census blocks in which it intends to meet its broadband deployment obligations under the program in South Dakota.

By this letter, CenturyLink is providing notice of these additional census blocks to the Commission.
