#### Dear Van Gerpen:

Magna5 LLC ("Company" fka X5 OpCo LLC) hereby notifies the South Dakota Public Utilities Commission ("Commission") that effective immediately, the Company is changing its name from X5 OpCo LLC ("X5 OpCo") to **Magna5 LLC**. Evidence of the Company's *Amended Certificate of Authority* issued by the State of South Dakota Office of the Secretary of State is attached.

On November 20, 2015, NovaTel Ltd., Inc. ("NovaTel") and X5 OpCo LLC ("X5 OpCo") submitted a joint courtesy *Notification* informing the Commission that X5 OpCo was acquiring assets, including subscriber accounts, of NovaTel, through a mutually negotiated agreement pending a grant of X5 OpCo's South Dakota Certificate of Authority to provide interexchange long distance services in South Dakota. On January 20, 2016, the Commission granted a Certificate of Authority to provide intrastate interexchange telecommunications services in South Dakota to X5 OpCo in the above-referenced proceeding

The Company's name change to Magna5 LLC is part of a rebranding initiative associated with the Company's completion of the asset acquisitions in South Dakota and throughout the U.S., and is not the result of a corporate reorganization or change of control. The Company's operations are otherwise unchanged. Company subscribers are being notified of the name change via billing insert and separate letter.
