This means that once Lifeline broadband discounts begin, you will be unable to obtain a Lifeline discount with another provider for 12 months if you switch your service.

If you purchase voice and <u>qualifying</u> broadband services, the federal Lifeline discount will apply to your qualifying broadband service, and the 12-month benefit transfer (Port Freeze) restriction will apply.

If you purchase voice service and a non-qualifying broadband service, you may receive both state and federal Lifeline discounts on your voice service. # Phone and Internet Discounts Available to CenturyLink Customers

The South Dakota Public Utilities Commission designated CenturyLink as an Eligible Telecommunications Carrier within its service area for universal service purposes. CenturyLink's basic local service rates for residential voice lines are \$21.25 per month and business services are \$32.00-\$38.40 per month. Specific rates will be provided upon request.
