Please accept this letter submitted on behalf of Flash Wireless, LLC ("Flash" or "Company"). Flash and its affiliate, ACN Communication Services, LLC ("ACN") are undertaking a corporate reorganization expected to be completed on January 1, 2023, whereby Flash will be consolidated into ACN and the resold wireless customers currently served by Flash will be transferred to ACN, which will services those customers under the same rates, terms and conditions. Existing customers of Flash will continue to be billed under the same brand name, making the transaction seamless to those customers.

The proposed corporate reorganization does not reflect a transfer of control, because there will be no change in the ownership or management of the company serving Flash's existing wireless customers. Following the reorganization, customers will be served by Flash's affiliate, ACN under the d/b/a of Flash Wireless or Flash Mobile. The Fictitious Business Name Registrations issued by the South Dakota Secretary of State are included as **Attachment A**.

Beginning January 1, 2023, ACN Communication Services, LLC will assume responsibility for all regulatory fees and associated with Flash Wireless, LLC customers.
