Global Tel*Link Corporation (the “Company”) respectfully submits this letter to notify the South Dakota Public Utilities Commission (the “Commission”) that the Company will operate under the new doing business as (“DBA”) name “ViaPath Technologies” in South Dakota. Enclosed is evidence of the DBA name as registered with the South Dakota Secretary of State. Please note, the legal name of the Company has not changed.

The Company holds a Certificate of Authority to Provide Alternative Operator Services and Interexchange Telecommunications Services, which was granted in Docket No. TC05-053 on May 26, 2005. Please update all Commission records to reflect the Company’s new DBA name.

The Company offers inmate calling services to correctional facilities in South Dakota, which allow incarcerated individuals to initiate telephone calls to their friends and family outside of the correctional facility. The DBA is reflected on the Company’s websites and interactive voice response (“IVR”) system. Only a handful of the Company’s customers receive regular monthly invoices (such as bail bondsmen, attorneys, etc.), and the DBA also will be reflected on those invoices.
