#### Section 63.71 Application of X2Comm, Inc.

X2Comm, Inc. ("X2Comm " or "Applicant"), hereby seeks authorization pursuant to Section 214 (a)

of the Communication Act of 1934, as amended, and 47 C.F.R. §63.71, to discontinue the provision of

interstate and international long distance services in the following states: Connecticut, Hawaii, Idaho,

Mississippi, New Mexico, Rhode Island and South Dakota. This proposed discontinuance will affect

approximately 98 existing customers.

Applicant is considered a non-dominant telecommunications carrier with respect to all of its services,

including those affected by the proposed discontinuance.

X2Comm provides the following information pursuant to Section 63.71 of the Commission's rules:

3. Date of Planned Service Discontinuance, Reduction or Impairment:

X2Comm, Inc. proposes to discontinue the services that are the subject of this Application on or about September 1, 2022, pending required federal and state regulatory approval of the discontinuance.

4. Points of Geographic Areas of Service Affected:

X2Comm proposes to discontinue all of its telecommunications services in Connecticut, Hawaii, Idaho, Mississippi, New Mexico, Rhode Island and South Dakota. These services are provided to existing customers and services will no longer be offered to new customers following the proposed discontinuance.

5. Brief Description of Types of Service Affected and Reason for Discontinuance:

The table below identifies the types of telecommunications services and affected customers impacted by the proposed discontinuance of service.

The services subject to the FCC's jurisdiction that are the subject of this request for authorization are interstate and international long distance. In March of 2022, X2Comm, Inc. entered into an agreement with Legent Comm LLC ("Legent Comm") and sold its customer base to Legent Comm. Legent Comm currently holds authority or is obtaining the same authority in most of the states where X2Comm has been providing services, but does not hold authority in Connecticut, Hawaii, Idaho, Mississippi, New Mexico, Rhode Island and South Dakota. Legent Comm has no plans to obtain authority in these states. Consequently, X2Comm must discontinue service to the affected customers in the aforementioned states.

As described below, X2Comm, Inc. is providing all affected customers with ample notice of the discontinuance and has established a dedicated toll-free customer service number to support customers impacted by the discontinuance.

## 6. Brief Description of Dates and Methods of Notice to All Affected Customers:

The Applicant has provided written customer notice of the planned discontinuance in accordance with the requirements of section 63.71 (a) of the Commission's Rules. Notice is being provided via 1<sup>st</sup> class U.S. mail to all affected customers on or before May 12, 2022. The notice is attached as Exhibit A.

A copy of this Application is being sent to the affected states Public Service / Utility Commissions and to the Governors' Offices, as well as to the Department of Defense, as required under Section 63.71, concurrent with this filing. A service list is provided in Exhibit B.

#### Conclusion

X2Comm, Inc. respectfully requests that the Commission approve its Section 63.71 Application to discontinue the services described herein. Pursuant to Section 214(a) of the Communication Act of 1934, as amended, and 47 C.F.R. §63.71, X2Comm, Inc. understands that this application will be automatically granted on the 31<sup>st</sup> day after the Public Notice is released, with no Commission notification to the Company, unless the Commission has notified the Company that the grant will not be automatically effective.



#### URGENT: Your long distance telephone services will be impacted unless you take action!

Dear Valued Customer,

X2Comm, Inc. d/b/a DC Communications will discontinue offering intrastate and interstate long distance services to all customers in Connecticut, Hawaii, Idaho, Mississippi, New Mexico, Rhode Island and South Dakota on September 1, 2022, pending applicable regulatory approvals. <u>Your service will be affected by this discontinuance</u>.

It is important that you migrate the services you are receiving from X2Comm, Inc. d/b/a DC Communications to an alternative provider <u>September 1, 2022</u> to avoid a <u>disruption of your long distance</u> <u>telephone services</u>. Failure to do so may result in insufficient time to transition your services to an alternative provider. Please contact X2Comm, Inc. d/b/a DC Communications as soon as possible to discuss your available options for an alternative service provider.

A filing is being made with the FCC and with the state Commission for approval of this discontinuance of service.

The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the Commission releases public notice of the proposed discontinuance. You may file your comments electronically through the FCC's Electronic Comment Filing System using the docket number established in the Commission's public notice for this proceeding, or you may address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the §63.71 Application of X2Comm, Inc. d/b/a DC Communications. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.
