Lifeline Documentation

Important Message from Range

Lifeline is a government program to help make communication services more affordable for low-income consumers. Lifeline allows customers to receive a discount for phone service or qualifying broadband service. Only eligible consumers may enroll.

Participation in Medicaid, Supplemental Nutrition Assistance Program (SNAP) (Food Stamps), Federal Public Housing Assistance (FPHA), Veterans Pension or Survivors Benefit Programs or Supplemental Security Income (SSI) can qualify you for Lifeline. Even if you do not participate in any of the above programs, you may still qualify for Lifeline based on your household income level. Contact Range for income guidelines.

The program is limited to one benefit per household and is nontransferable.

Anyone who willfully makes false statements in order to obtain Lifeline can be punished by fine, imprisonment, or can be barred from the program.

**Additional benefits and eligibility options are available to consumers residing on Tribal lands.

LIFELINE

Lifeline is the FCC's program to help make communications services more affordable for low-income consumers. Lifeline discounts can be applied to voice and broadband service. Only eligible consumers may enroll. Participation in Medicaid, SNAP, (formerly called food stamps) FPHA (federal public housing assistance program), SSI (supplemental security income) or Veteran's Pension & Survivor Benefit can qualify you for Lifeline. Even if you do not participate in any of the above programs, you may still qualify for Lifeline based on your household income level. Additional benefits and eligibility options are available to customers residing on Tribal lands.

The program is limited to one benefit per household.

Contact your local telephone company for guidelines. The World office can be reached at 1-800-647-9841.

Consumers may also reach out to the Lifeline Eligibility Verifier (National Verifier). The Lifeline National Eligibility is a centralized system that determines whether subscribers are eligible for Lifeline. For those consumers who wish to apply for Lifeline directly through the National Verifier can use the consumer portal at www.CheckLifeline.org to submit a paper application directly to the Lifeline Support Center or they can submit the application online.

Lifeline is a government benefit program and anyone who willfully makes false statements in order to obtain a benefit can be punished by fine or imprisonment or barred from the program.
