SECTION 63.71 APPLICATION

CenturyLink Communications, LLC (FRN: 0018-4219-41), (referred to herein as "CenturyLink") hereby applies for authority to discontinue service to its remaining customers of a single Voice over Internet Protocol ("VoIP") service that is operating on a VoIP platform with aging support capabilities.

CenturyLink submits the following information in support of its application:

1. Name and address of carrier

CenturyLink Communications, LLC 100 CenturyLink Drive Monroe, LA 71203

2. Date of planned service discontinuance

CenturyLink plans to discontinue the Affected Services on December 31, 2024, or as soon thereafter as any necessary regulatory approvals are obtained.

3. Points of geographic areas of service affected

CenturyLink seeks authority to discontinue a VoIP service in all 50 states, the District of Columbia and Puerto Rico.

4. Brief description of the type of services affected

CenturyLink seeks to discontinue the following VoIP service:

Engage is a nationwide cloud communication solution providing PBX or Business Line replacement for voice plus collaboration and inbound call center capabilities.

5. Brief description of the dates and methods of notice to all affected customers

CenturyLink sent a written notification of the planned discontinuance to customers affected by this proposed discontinuance in accordance with Section 63.71(a) of the Commission's Rules. Customer notifications were included as a message printed on all bill statements sent to affected customers between November 1, 2024 and November 24, 2024. The bill message will be included on all bill statements again in December 2024. The language of the bill message notification is attached to this application (Attachment A).

6. Dominance of carrier with respect to the service to be discontinued

CenturyLink is considered non-dominant with respect to the services to be discontinued.

7. Other Information

In accordance with 47 C.F.R. § 63.71(a), CenturyLink has mailed a copy of this application to the Governor and public utility commission of each of the affected states and jurisdictions identified in Paragraph 3 above, to any federally-recognized Tribal Nations with authority over the Tribal lands in the geographic areas identified in Paragraph 3 above, as well as to the Special Assistant for Telecommunications under the Secretary of Defense.
