SECTION 63.71 APPLICATION

Lumen Technologies, Inc. (Lumen) hereby applies for authority pursuant to Section 63.71(k) of the Federal Communications Commission's (Commission) rules, 47 C.F.R. § 63.71(k), and Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, to grandfather low-bandwidth interstate private line services (Affected Services) provided by certain Lumen Competitive Local Exchange Carrier (CLEC) and Interexchange Carrier (IXC) companies (Lumen CLEC/IXC Affiliates)¹ in all 50 states, Washington, D.C., and Puerto Rico.

They offer transmission speeds ranging from the DS0 level up to and including Optical Carrier Network (OCN) speeds. Circuits at DS0, DS1, Fractional DS1 up to 512 kbps, E1, DS3, E3, OC3/STM1,

OC12/STM4, OC48/STM16 and OC192/STM64 levels may be available between any two POP locations.²

The public convenience and necessity will not be adversely affected by the grandfathering of the Affected Services, as existing customers have been given significant notice of these changes, and potential customers of these services can seek alternative service arrangements that offer the same or superior capabilities, such as Lumen's Ethernet services and similar services offered by numerous other providers.

5. Brief description of the dates and methods of notice to all affected customers

Lumen notified its retail customers of the planned grandfathering of the Affected Services in a letter sent via United Service Parcel Service or U.S. Mail on April 1, 2025.³ Those customers were notified that the proposed grandfathering would take effect on June 1, 2025, or as soon after that date as authorized by the relevant regulatory commissions. Copies of the two forms of customer notification letters Lumen used are attached hereto. (*See* Attachments B and C.)

6. Whether the carrier is considered dominant or non-dominant with respect to the services to be discontinued, reduced or impaired

The Lumen CLEC/IXC Affiliates are non-dominant carriers with regard to the services to be grandfathered.

7. Service

In accordance with 47 C.F.R. § 63.71(a), Lumen has mailed a copy of this application to the Governor and public utility commission of each affected state identified in Paragraph 3 above, to any federally-recognized Tribal Nations with authority over the Tribal lands in the
