Re: Notification of Transfer of Control of Truphone, Inc. to TP Global Operations Limited

Dear Staff:

1Global Operations (US) Inc. f/k/a Truphone, Inc. (“1Global”), a wholly-owned subsidiary of TP Global Operations Limited (“TP Global”), hereby submits this notification of a transfer of control of 1Global to TP Global (collectively, the “Parties”).¹

The transfer of control has been approved by the Federal Communications Commission (“Commission”).² It is the Parties’ understanding that the laws of South Dakota and the rules of the Commission do not require any Commission approval or other action with respect to the proposed transaction. Accordingly, this letter is submitted for informational purposes.

Description of the Parties

1Global Operations (US) Inc.

1Global, a Delaware corporation, is a global mobile network operator, accredited by the Global System for Mobile Communications Association (“GSMA”), that provides global mobile voice and data services. 1Global is headquartered in London and has offices in ten other

countries across four continents. 1Global offers eSIM-based GSM mobile services, utilizing telephones, tablets, and the Internet of Things (“IoT”), to both businesses and individuals, as well as mobile phone calls, and text recording services for businesses, remote SIM provisioning, and related services. 1Global has a customer base that includes more than 3,500 multinational enterprises in 196 countries. 1Global’s SIM technology, which integrates with eSIM, switches to operate like a local SIM (with local data speeds, call quality, and costs) that enables customers to have multiple international numbers on a single SIM.

TP Global

Founded in 2022, TP Global operates an internationally recognized global mobile network that is accredited by the GSMA. TP Global is headquartered in London, with research and development facilities in Lisbon. It has over 400 employees working in twelve countries, and currently operates as a mobile virtual network operator (“MVNO”) in the United States, the United Kingdom, Germany, Spain, France, the Netherlands, Poland, Hong Kong, and Australia. TP Global provides eSIM-based GSM mobile services to businesses and individuals, with products that include mobile phone call and SMS recording services for businesses, remote SIM provisioning, IoT solutions, “Telco-as-a-Service” for travel and consumer companies, and roaming for consumers.

Description of the Transaction

Pursuant to a definitive transaction agreement executed on January 24, 2023, by Truphone Limited and TP Global, TP Global indirectly obtained 100 percent of the voting and equity interest in 1Global’s predecessor, Truphone, Inc., which was wholly owned by Truphone Limited. Specifically, TP Global acquired 100 percent of the voting and equity interest in TP US Operations, Inc., a corporation organized under the laws of Delaware, which in turn, directly owned 100 percent of the voting and equity interest in Truphone, Inc. The transaction was consummated on June 28, 2024.³ Upon consummation, Truphone Limited became a separate and distinct entity and no longer had any connection to Truphone, Inc.


