SECTION 63.71 APPLICATION OF IDT America, Corp.

IDT America, Corp. ("IDT"), seeks authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(a), and Section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue long-distance, local exchange and toll-free voice services throughout the continental United States. The number of affected customers, per service, are: 628 long distance, 934 bundled local exchange and long distance and 257 toll free customers.

IDT provides the following information pursuant to Section 63.71 of the Commission's Rules:

2. Date of Planned Service Discontinuance

IDT plans to discontinue the services noted below ("Affected Services") on or about August 10, 2026, pending required federal and state regulatory approval of the discontinuance.

3. Points of Geographic Areas of Service Affected

IDT proposes to discontinue the Affected Services throughout all of the forty-eight states within the continental United States as well as the District of Columbia. IDT will no longer provide the Affected Services. The number of customers affected, by service, is listed on **Exhibit C**.

4. Description of Services Affected and Reason for Discontinuance

The Affected Services provided by IDT are: intraLATA and interLATA toll (long distance); long distance bundled with local exchange service (bundled local exchange and long distance); and toll service. The Services are being discontinued because, due to changes in the telecommunications marketplace in recent years, IDT can no longer provide service in a cost-effective manner.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers

IDT sent a written notification of the planned discontinuance to customers affected by the proposed discontinuance in accordance with Section 63.71(a) of the Commission's Rules. Customer notifications were sent by First Class U.S. Mail on July 1, 2026. A copy of the notification is attached to this application (**Exhibit B**).

6. Whether the Carrier is Considered Dominant or Non-dominant with Respect to the Service to be Discontinued

IDT is considered non-dominant with respect to the services to be discontinued.

Other Information

In accordance with Section 63.71(a) of the Commission's Rules, a copy of this application is being mailed concurrently with its filing to the Public Utilities Commission and Governor of each affected state as well as to the Department of Defense. A service list is provided at **Exhibit A**.

CONCLUSION

The public convenience and necessity will not be adversely affected by the discontinuance of the services described herein. Advance notice has been provided to all affected customers, giving them ample time to arrange substitute services, which are readily available from other providers. Therefore, IDT respectfully requests that the Commission approve its Section 63.71 Application to discontinue the services described herein. Pursuant to Section 214(a) of the Communications Act of 1934, as amended and 47 C.F.R. Sec. 63.71, IDT understands that this application will automatically or, in the alternative, decline to act, thereby resulting in the approval of this Section 63.71 application will be automatically granted on the 31st day after the Public Notice is released, with no Commission notification to IDT, unless the Commission has notified IDT that the grant will not become automatically effective.

IMPORTANT NOTICE REGARDING YOUR IDT TELECOMMUNICATIONS SERVICES

July 1, 2026

Dear IDT Customer:

IDT America, Corp. ("IDT") regrets to inform you that we will be discontinuing your IDT telephone service, effective on or about August 15, 2026.

Beginning on or about August 15, 2026, your IDT phone service will no longer be available, and your service will be disconnected. To avoid an interruption in your phone service, you must select an alternate service provider prior to this date.

A filing is being made with the FCC and your state utility commission for approval of this discontinuance of service.

The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the Commission releases public notice of the proposed discontinuance. You may file your comments electronically through the FCC's Electronic Comment Filing System using the docket number established in the Commission's public notice for this proceeding, or you may address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the § 63.71 Application of IDT America, Corp. Comments should include specific information about the impact of this proposed discontinuance (or reduction or impairment) upon you or your company, including any inability to acquire reasonable substitute service.
