Re: SQF, LLC d/b/a Verta – Notification Regarding Assumed Name

Dear Executive Director Mohr:

SQF, LLC ("SQF") hereby notifies the South Dakota Public Utilities Commission (the "Commission") of its intention to do business under the assumed name of "Verta."

SQF is a Delaware limited liability company and is authorized by the Commission to provide local exchange services pursuant to a Certificate of Authority granted July 3, 2018, in Docket No. TC18-014. SQF's Fictitious Name Registration from the North Dakota Secretary of State is provided as **Attachment A**.

The addition of SQF's assumed name to the name "SQF, LLC" does not entail any merger or other transaction disrupting the existence of SQF. SQF's assumed name also does not affect the rates, terms or conditions of service provided by SQF, and customers will continue to be served by the same entity from whom they previously obtained service. Because SQF is adding the assumed name to the end of its current name, there will likely not be any confusion. Further, SQF is not currently providing telecommunications services to any customers in South Dakota. For these reasons, notice to customers of the addition of the assumed name should not be necessary.
