CHAIRMAN BURG: CT02-032, In the Matter of the Complaint Filed by Robert A. Fogg Junior, Martin, South Dakota Against Cellular One Regarding Billing.

Today shall the Commission grant

Cellular One's Motion for summary judgment? And I

will take discussion on whether we should grant the

Motion of Summary Judgment.

MR. WIECZOREK: Mr. Chairman, this is Talbot Wieczorek. I made the Motion on behalf of Western Wireless and I briefed it and I'm going to provide a copy, of course, with the filing so I'm just going to hit a couple of highlights on it. I don't believe there's any really disputed facts that are material to the issues that were listed in the Order For and Notice of Hearing.

Essentially, walking down those issues, one was an issue that we conducted a credit check on Mr. Fogg before we issued him wireless service.

That is true. That was part of the contract when he signed in so we don't believe there's an issue of law or any violation for doing a credit check before initiating service with him.

As to the failing to provide the credit report, I believe that's been fully explained.

It's not a practice to provide that information if requested in a short period of time. Western Wireless doesn't keep that information. He requested it several weeks after the credit check was done. At that time they didn't have the information anymore, but they did a letter to him that's been attached to the affidavit that was submitted in support of this Motion giving him where he can get his credit information from the two sources Western Wireless obtains that information.

There was a \$350 deposit assessed as part of the contract. We believe that's within the legal requirements -- or within the law as provided to Western Wireless. We believe that falls under rate setting with deposits and any interest to be charged on deposits, our rate setting.

I raised the issue of whether the Commission would have jurisdiction to even assess what amount of deposit be appropriate given the federal law, and the fact that for commercial mobile service — the fact it's a reasonable deposit, he agreed to it also in his contract before commencing service.

The billing -- and these are issues 5.

There's some different billing issues. There was a

delay in posting the billing because the third party selling the service did not forward the check immediately. As soon as Western Wireless found out about that, they actually sent a driver from -- a manager from Rapid City to go pick up the check and immediately had it posted to his bill. And that's issues 5A and B.

As to the double billing, Mr. Fogg has taken it upon himself to send his payment to corporate headquarters as opposed to the payment center, which has delayed posting of his payments and thus the bill will show up unpaid on his next bill because it takes time for it to go to corporate headquarters and then they have to ship it down to Phoenix.

That's not how he's supposed to pay it, and he's chosen to do that so as to whether -- I can't see how that can be an issue with Western Wireless when he won't send it to the proper billing location.

Other information, I'll just briefly -- as to Item 6, there is a reconnect fee if he's disconnected. He's never been charged that.

As to Item 7, it's not common practice and I don't believe there's any law that requires

Western Wireless to give out full name and addresses of Western Wireless customer service representatives.

As to Item 8, we don't know of any tape recordings that we did. The only time that we record stuff is for customer assurance. They don't keep those recordings so if they had recorded anything, it doesn't exist to date.

And then, finally, as to interest, that kind of drops back into whether the Commission has jurisdiction. But the contract does not allow for interest paid and specifically states that it can't be modified verbally. And we're not exactly sure where he came up with the rate of 28 percent.

I would take any questions you might have on the briefing or just for summary of the issues.

CHAIRMAN BURG: Mr. Fogg, what we're doing is a summary judgment is saying that we will make a determination based on all the facts that are in front of us today. And so the question being today is do you have an argument of why we should not use the summary judgment proceedings to determine this question?

MR. FOGG: The simple point becomes
