1 CHAIRMAN SAHR: Next item, No. 2 on our agenda, is TC04-077, In the Matter of the 2 3 Petition of James Valley Cooperative Telephone Company For Suspension of Intermodal Local Number 4 5 Portability Obligations. 6 And the question today, if a settlement has been reached, shall the Commission dismiss and close the docket? 8 And the parties here are James Valley and 9 Western Wireless; is that correct? 10 MS. WIEST: And Midcontinent. 11 CHAIRMAN SAHR: And Midcontinent. 12 Anyone appearing on behalf of either of those three 13 14 entities? 15 MS. CREMER: Jim Cremer from James 16 Valley. MR. WIECZOREK: Talbot Wieczorek 17 18 from Western Wireless. CHAIRMAN SAHR: Thank you. Mary, I 19 20 know you're on the line for Midcontinent. 21 Mr. Cremer, do you want to go ahead and 22 proceed? 23 MR. CREMER: I think the parties 24 have reached a written stipulation consistent with 25 the oral stipulation that was entered on June 22.

parties. All parties have approved the written stipulation, although it has not yet been signed. I also provided to Rolayne a copy of the stipulation and proposed order approving it, and I would ask the Commission to approve the stipulation and enter the order once you receive the actual CHAIRMAN SAHR: Thank you. Mr. Wieczorek, anything to add? MR. WIECZOREK: No, Mr. Chairman. The stipulation has been agreed to. It just needs to be circulated. I also believe there has been a tentative or potential order provided by Mr. Cremer that staff has had a chance to review. CHAIRMAN SAHR: Thank you. MS. LOHNES: No, we do not oppose --CHAIRMAN SAHR: You broke up, Mary. You started saying we do not oppose, I believe. We do have a court reporter here in the room. needs you to speak up as loudly as you can so we can hear you clearly. Could you please restate

MS. LOHNES: Certainly. We would

agree with the settlement that has -- (Inaudible).

CHAIRMAN SAHR: We lost you after we agree with the settlement. Do you have anything else to add beyond that?

MS. LOHNES: No, I don't.

CHAIRMAN SAHR: Thank you. Any

comments from staff?

Ms. Wiest?

MS. WIEST: Yes. I know that the Commissioners just received this right before the hearing, the meeting today, so I'm not sure if you're prepared to have any questions about this today.

One of the issues that came up and is -- I'll just point out is reflected in the proposed order is that -- the question is how do we deal with non-Interveners. And that is actually spelled out in paragraph 5 of the actual stipulation, and what would happen is that any non-Intervener is subject to the same terms and conditions as are laid out here for both -- it would be wireless would be subject to the same wireless and then wireline would be subject to paragraph 3 conditions and then the wireless or wireline carrier could petition the

Commission for modification of that.

And talking about going forward with respect to what the suspension or modification would be, the way I see it is that I think if the Commission would agree with this type of stipulation is that -- and I don't know that you want to actually enter the order that they've proposed here. usually write our own orders.

But the way I could see it is that the Commission would actually enter an order that would modify LNP requirements consistent with the terms and conditions of the stipulation. And the reason that you might want to look at doing it that way is that I think it's possible the FCC could come out with some future orders that may not necessarily be consistent with what the parties have agreed to in the stipulation, and that is the direct connection with James Valley. And I think if you had an order out there that stated that this was the modification of LNP requirements consistent with the stipulation, then that may have the effect of binding any other future wireless providers who want to enter -- who give a bona fide request.

I see that as one of the main issues, I guess. And, like I said, you just got it so it is possible

that you may want to just review it further and consider it at the next meeting, or if you're prepared to go forward with it today, that's fine. At this point I have no problems recommending approval of the stipulation. As far as the order goes, I would think you'd want to review that and see if that's the type of language that you want in that and if you think that you want to put an order that says that you're modifying LNP requirements for future wireless or wireline carriers who want LNP.

And the other point I was going to point out is that if you look at 2E, the term of the agreement is for three years. And so how I would read it is that since the term of the stipulation is for three years, any order that you put in approving the stipulation and any order that you may put in stating that the stipulation is really a modification of LNP requirements, that would also only be good for three years and after three years I guess LNP, you know, would be implemented and the parties would have to negotiate any future terms and conditions on their own.

CHAIRMAN SAHR: Thank you.

Ouestions or comments from Commissioners or

advisers? 1 Well, I agree 2 COMMISSIONER BURG: with Rolayne. I think we can go ahead and 3 approve -- (Inaudible). CHAIRMAN SAHR: Jim, we have a court reporter in the room, and she needs to be able to 6 transcribe what you're saying so could you please 7 8 attempt to speak more loudly and clearly so that 9 she can get that on the record. 10 COMMISSIONER BURG: I agree with 11 Rolayne that we can probably approve it today but wait to write the order -- (Inaudible). 12 13 CHAIRMAN SAHR: Jim, we lost you 14 about midway into your third sentence. 15 COMMISSIONER BURG: I'll just say I'll move approval then. 16 17 VICE CHAIR HANSON: Second. 18 MR. SMITH: Can I ask a question on this? 19 20 CHAIRMAN SAHR: Please go ahead. 21 MR. SMITH: Again, I haven't had 22 much time to look at this thing, but is this 23 stipulation in any way conditional upon a 24 Commission's approval of a particular order form --MR. CREMER: John, Jim Cremer. 25 Ιt

is not. I think Rolayne's comments are appropriate. What we have proposed in the order I think takes care of her concerns, and I think once you have drafted an order I think it would be appropriate to circulate it back to the parties in the event that the order isn't consistent with the intent of the parties in the stipulation, although what Rolayne said I think is consistent with what we want to do. I think once we see the order, that would resolve these issues.

So it might be appropriate to approve the stipulation subject to recirculation of the order so that the parties if we have objections to the language in the order could raise objections at that time.

MR. SMITH: Jim, let me ask you a question about that. If that is the case, do we actually gain anything by approving that stipulation today, or should we attempt to put together an order that meets Ms. Wiest's concerns and then if -- because is it possible -- is it at least possible that there might be some effect on what you've stipulated to?

MR. CREMER: I think there is a possibility. I don't think it's going to be a

problem so it might make sense to defer this until the proposed order is circulated.

CHAIRMAN SAHR: And I do have some questions. Procedurally to me the question today is if the settlement has been reached shall we dismiss and close the docket. Now we're talking about approving a stipulation and we're talking about approving an order that the parties put together and have put forward before this Commission perhaps with modification, perhaps not.

I wonder if procedurally we're ready to act on this. And I certainly applaud the parties for getting this together. At the same time I believe the paperwork came in this morning; is that correct?

MS. WIEST: Yes. I would agree. I think that it did come in -- I just got it at 9 o'clock, and I handed it out. So I could certainly understand if the Commission would like to defer this, both the stipulation and any possible order. And because I think it's something that needs to be thought through.

I mean, this is just my opinion and the question is whether you really want to put in the order which has the language about what you're

doing is you're really modifying LNP requirement for non-Interveners. So I have no problem with holding this off until the next Commission meeting.

CHAIRMAN SAHR: Mr. Cremer and Mr. Wieczorek and Ms. Lohnes and, again, I do commend your efforts in getting this before the Commission, but I think it's important that we take a careful look at this and review it and try to follow -- I guess make sure that we're following our own docketed items as far as what the issues are at hearing.

Is there a problem with us waiting until our next scheduled meeting, and certainly if there is -- and I think that's August 17. If there is, I certainly would not be opposed to doing an ad hoc meeting sometime later this week and taking care of it with that. Because I don't want to see the agreement fall apart for failure of the Commission to move on this in a timely fashion.

At the same time, I do think it's important to look at the stipulation, to discuss the potential order and to make sure that procedurally we're not running afoul of our own agenda. So is there a problem with giving us a few days to look at this and would you be willing to wait until the

August 17 hearing or would you prefer to just see 1 this get taken care of this week if possible? 2 MR. CREMER: Mr. Chairman, I don't 3 have a problem with continuing this. If the 4 5 Commission has an opportunity to look at it before August 17 and you want to do an ad hoc, that's fine 6 with me. If you don't and want to continue until 7 the 17th, I don't have an objection to that. 8 CHAIRMAN SAHR: Mr. Wieczorek. 9 MR. WIECZOREK: I have no objection 10 to finishing until the 17th, Mr. Chairman. I 11 looked at the James Valley filing. It wasn't made 12 until April so based on the decision time line 13 under the statute you have plenty of time even if 14 we continue it until the 17th. 15 CHAIRMAN SAHR: Ms. Lohnes, can you 16 17 speak on behalf of Midcontinent? MS. LOHNES: We're fine continuing 18 19 it. 20 MR. SMITH: As I understand it, 21 Cheyenne River isn't ready to go today either, are 22 they? So we're going to be hearing this again on the 17th. 23 Yes. Thank you. 24 MS. ROGERS: And I may actually be the fly in the ointment because I 25

think I was the one who started raising these concerns about what's going to be the real effect on other wireless carriers that did not intervene. With regard to CRST we don't have final language even on the stipulation. I think we have a basic agreement, but I think we need to explore even with Rolayne and staff a little bit more how we're going to handle this in the order.

And I do have, you know, some other drafted language that we can look at and some other potential ways to address this. But we would prefer that on behalf of CRST that you defer this and that we explore it a little bit more.

CHAIRMAN SAHR: With that in mind, I'm going to dissent to Commissioner Burg's Motion, and I think we need to take a little bit more time to look at this and make sure procedurally we're in the right spot. Again, I don't want to take so much time to see this throw off any of the potential agreements because I'm a firm believer if the parties come up with something that's good for them and the consumers, we're all better off.

MS. ROGERS: CRST has no intention of walking away from the agreement. It does not jeopardize the agreement from our perspective, and

5	CHAIRMAN SAHR: So procedurally we
6	have a Motion by Burg, a second by Commissioner

10	VICE CHAIR HANSON: Mr. Chairman,

14	second.
