On May 25, 2000, the Public Utilities Commission (Commission) received a complaint filed by Evelyn Bultsma, Sioux Falls, South Dakota (Complainant), against Telco Billing, Inc. (Telco) regarding unauthorized billing and switching of services.

On May 25, 2000, the complaint was faxed to Telco. Pursuant to ARSD 20:10:01:09, Telco was notified that it must satisfy the complaint or file an answer in writing with the Commission by June 14, 2000. The Commission has not received an answer from Telco to this complaint.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

By order dated June 30, 2000, a hearing was scheduled for July 20, 2000, in Room 412 of the State Capitol Building, 500 E. Capitol, Pierre, South Dakota. Commission Staff was informed that settlement had been reached in this matter, so therefore the hearing is cancelled. It is therefore

ORDERED, that the hearing scheduled for July 20, 2000, is cancelled.
