On April 26, 2001, the Public Utilities Commission (Commission) received a complaint filed by Rex and Lori Caldwell, Spearfish, South Dakota (Complainants), against Black Hills Power and Light Company (BHPL) regarding easement and reimbursement issues.

On April 30, 2001, the complaint was faxed to BHPL. Pursuant to ARSD 20:10:01:09, BHPL was notified that it must satisfy the complaint or file an answer in writing with the Commission by May 21, 2001. On May 21, 2001, the Commission received a letter response from BHPL.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26 and 49-34A, specifically 49-34A-2, 49-34A-2.1, 49-34A-3, 49-34A-9, 49-34A-10, 49-34A-26, 49-34A-27, 49-34A-39, 49-34A-40, and 49-34A-58.

A hearing shall be held on June 20, 2001, in Room 412 of the State Capitol Building, 500 E. Capitol, Pierre, South Dakota, immediately following the hearings for Dockets CT01-021 and CT01-022. Docket CT01-021 is scheduled to begin at 8:30 A.M. All persons testifying will be subject to cross-examination by the parties.

The issue at the hearing is whether BHPL committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate.

The hearing shall be an adversary proceeding conducted pursuant to SDCL Chapter 1-26. All parties have the right to be present and to be represented by an attorney. These rights and other due process rights shall be forfeited if not exercised at the hearing. If you or your representative fail to appear at the time and place set for the hearing, the Final Decision will be based solely on the testimony and evidence provided, if any, during the hearing or a Final Decision may be issued by default pursuant to SDCL 1-26-20. After the hearing, the Commission will consider all evidence and testimony that was presented at the hearing. The Commission will then enter Findings of Fact, Conclusions of Law, and a Final Decision regarding this matter. As a result of the hearing, the Commission shall determine whether BHPL committed an unlawful or unreasonable act, rate, practice, or omission and, if so, order any appropriate relief. The Commission's Final Decision may be appealed by the parties to the state Circuit Court and the state Supreme Court as provided by law. It is therefore

ORDERED, that a hearing shall be held at the time and place specified above on

the issue of whether BHPL committed an unlawful or unreasonable act, rate, practice or omission and, if so, what relief would be appropriate.
