On August 3, 2001, the Public Utilities Commission (Commission) received a complaint filed by Joan M. Horstman, Sioux Falls, South Dakota (Complainant), against Touch America, Inc. (Touch America) and Sprint Communications Company L.P. (Sprint) regarding unauthorized switching of services and billing for services.

On August 7, 2001, the complaint was faxed to Touch America and Sprint. Pursuant to ARSD 20:10:01:09, Touch America and Sprint were notified that they must satisfy the complaint or file answers in writing with the Commission by August 27, 2001. On August 23, 2001, Sprint filed a motion to dismiss. The Commission has not received answers from Touch America or Sprint to this complaint. At its September 7, 2001, meeting, the Commission considered Sprint's motion to dismiss. The Commission granted Sprint's motion to dismiss. On September 7, 2001, Complainant filed a request to add Qwest Corporation (Qwest) as a party.

On September 18, 2001, at a regularly scheduled meeting, the Commission considered this matter. Qwest did not object to being added as a party.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

The Commission voted to grant Complainant's request to add Qwest as a party. It is therefore

ORDERED, that Qwest shall be added as a party in the above captioned matter, and that the complaint shall be forwarded to Qwest and Qwest shall file with the Commission its answer in writing within twenty (20) days of service of this order.
