On December 7, 2001, the Public Utilities Commission (Commission) received a complaint filed by Black Hills FiberCom, L.L.C., Rapid City, South Dakota (Complainant), against Qwest Corporation (Qwest) regarding Qwest Corporation's Failure and Refusal to Pay Black Hills FiberCom, L.L.C. for Accrued Minutes of Local/EAS Traffic Incurred by Qwest Corporation and Billed by Black Hills FiberCom, L.L.C.

On December 10, 2001, the complaint was faxed to Qwest. Pursuant to ARSD 20:10:01:09, Qwest was notified that it must satisfy the complaint or file an answer in writing with the Commission by December 31, 2001. The Commission has not received an answer from Qwest to this complaint. On December 28, 2001, the Commission received a Motion to Dismiss, Memorandum of Law in Support of Motion to Dismiss and Affidavit of Larry Toll from Qwest. On January 17, 2002, the Commission received a Stipulation of Voluntary Dismissal signed by Complainant and Qwest.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-15, 49-31-18, 49-31-19, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, and ARSD Chapter 20:10:01.

On January 24, 2002, at a regularly scheduled meeting, the Commission considered this matter. Upon recommendation of Commission Staff, the Commission voted to dismiss the complaint and close the docket. It is therefore

ORDERED, that the complaint shall be dismissed and the docket closed.
