On July 18, 2005, the Public Utilities Commission (Commission) received a complaint filed by South Dakota Network, LLC (Complainant) against Global Crossing Telecommunications, Inc. (Global) regarding access charges.

On July 21, 2005, the Commission electronically transmitted notice of the filing and the intervention deadline of August 5, 2005, to interested individuals and entities. No petitions to intervene or comments were filed.

The Commission finds that it has jurisdiction in this matter for purposes of entering this order pursuant to SDCL Chapters 1-26, 49-1, including 49-1-9 and 49-1-11, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-11, 49-31-76 and 49-31-89, and ARSD Chapters 20:10:01 and 20:10:27 through 20:20:29.

It is therefore

ORDERED, that the following procedural schedule shall be followed:

Depositions shall be scheduled by the parties in accordance with the Rules of Civil Procedure for dates prior to December 30, 2005, except as agreed upon by the parties or as ordered by the Commission.
