On June 21, 1996, the Public Utilities Commission (Commission) received an application from MidAmerican Energy Company (MidAmerican) requesting approval to revise certain electric tariff sheets. MidAmerican asked for approval of the following revised tariff sheets of its Electric Rate Schedule:

Electric Tariff No. I

Section No. 3

1st Revised Sheet No. D-IV Canceling Original Sheet No. D-IV

1st Revised Sheet No. D-1 Canceling Original Sheet No. D-1

1st Revised Sheet No. D-5 Canceling Original Sheet No. D-5

1st Revised Sheet No. D-6 Canceling Original Sheet No. D-6

MidAmerican's application stated: "we have discovered that temporary services cannot be billed under either residential or small general service rates. Our intent is that temporary residential services for home construction be served under residential rates and that all other temporary services be served under small general service rates. The... revisions will allow temporary services to be billed under the appropriate residential or small general service rate."

A regularly scheduled July 9, 1996, meeting, the Commission discussed final approval of the application. Commission Staff recommended approval of the tariff revisions, effective July 24, 1996.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10 and 49-34A-12. The Commission found the tariff changes are just and reasonable and approved the revised tariffs. As the Commission's final decision in this matter, it is therefore

ORDERED that MidAmerican's aforementioned revised tariffs are approved and shall be effective for service rendered on and after July 24, 1996.
