On February 28, 2007, Montana-Dakota Utilities Co. (MDU) filed a petition to temporarily modify the on-peak time period of MDU's Time-of-Day service tariffs. The purpose is to accommodate a federally mandated trial change in the Daylight Savings Time (DST). The Company proposes to apply these tariff modifications in March 2007, coincident with the change in DST. The proposed tariffs are:

At its ad hoc meeting of March 7, 2007, the Commission considered approval of the application. Commission Staff recommended approval.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapter 49-34A. Further, the revisions are just and reasonable and shall be approved. As the Commission's final decision in this matter, it is therefore

ORDERED, that MDU's revised tariffs as described above are approved and shall be effective for service rendered on and after March 7, 2007.
