**ORDER APPROVING  
TARIFF REVISIONS  
  
EL10-009**

On July 14, 2010, the Public Utilities Commission (Commission) received an application from MidAmerican Energy Company (MidAmerican) for approval to revise its Rider No. 54 – Qualifying Cogeneration and Small Power Production Purchases tariff. MidAmerican has requested an effective date of August 15, 2010, for the proposed modifications to the rate schedules. The revised tariff sheets are as follows:

On July 14, 2010, the Commission electronically transmitted notice of the filing and the intervention deadline of July 30, 2010, to interested individuals and entities. No parties sought intervention.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, and 49-34A-12.

At its September 14, 2010, meeting, the Commission considered this matter. Commission Staff recommended approval to revise MidAmerican's Rider No. 54 – Qualifying Cogeneration and Small Power Production Purchases tariff with an effective date of September 14, 2010. The Commission finds the revisions are just and reasonable and approves the revisions. It is therefore

**ORDERED**, that MidAmerican's request to revise its Rider No. 54 – Qualifying Cogeneration and Small Power Production Purchases tariff is hereby granted. It is further

**ORDERED**, that the above-mentioned tariff is approved and are effective for services rendered on and after September 14, 2010.
