At its regularly scheduled meeting of July 26, 2011, the Commission considered this matter. Commission Staff recommended approval of Otter Tail's revised tariffs. The Commission finds the revisions are proper and approves the revisions. It is therefore

ORDERED, that Otter Tail's request for approval of tariff revisions is hereby granted. It is further

ORDERED, that the above-mentioned tariff revisions are approved and effective on and after July 30, 2011.
