**ORDER GRANTING APPROVAL
OF ELECTRIC SERVICE
TERRITORY BOUNDARY
CHANGES**

On February 29, 2012, Commission Staff filed an Electric Service Territory Boundary Agreement between Grand Electric Cooperative, Inc. and Faith Municipal Electric. This filing is made pursuant to current efforts of the PUC to verify electric territory mapping data for conversion to electronic format and use in a Geographic Information System (GIS) database. With the assistance of the above-referenced utilities, Commission Staff has confirmed the service territory boundary shared by these utilities and has prepared updated mapping information. On April 6, 2012, Commission Staff filed an updated agreement to incorporate non-substantive changes to the legal description and maps included as part of the agreement. These changes were made in order to clarify the legal description and to include certain information inadvertently excluded from the original filed maps.

On March 8, 2012, the Commission electronically transmitted notice of the filing and the intervention deadline of March 23, 2012, to interested individuals and entities. No petitions to intervene or comments were filed.

At its regularly scheduled meeting on April 10, 2012, the Commission considered this matter. Commission Staff requested approval of the agreement in order to update official electric service territory mapping data to accurately reflect current service territories served by the utilities. The Commission voted unanimously to approve the agreement.

The Commission finds that it has jurisdiction over the matter pursuant to SDCL 49-34A, specifically, 49-34A-4, 49-34A-42, 49-34A-43 and 49-34A-55. It is therefore

ORDERED, that the request for approval of the agreement to update mapping data to reflect current electric service territory boundaries shared by Grand Electric Cooperative, Inc. and Faith Municipal Electric is hereby granted.
