On November 1, 2017, the South Dakota Public Utilities Commission (Commission) received a petition from Otter Tail Power Company (OTP) for approval of its 2018 Transmission Cost Recovery (TCR) Rider. The update includes the tracker balance estimated for the end of the current recovery period so that no over or under-recovery of TCR costs occurs. OTP's petition proposed a March 1, 2018, effective date.

On November 2, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of November 17, 2017, to interested persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On November 27, 2017, the Commission issued an Order Assessing Filing Fee. On January 29, 2018, OTP filed a Supplemental Filing with revised Attachments 1 through 25. On February 16, 2018, the Commission's Staff (Staff) filed a Staff Memorandum recommending Commission approval of the TCR revenue requirement and resulting rates as filed in the Supplemental Filing on January 29, 2018. The revised tariff sheet effective for service rendered on and after March 1, 2018, is as follows:

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-25.1 through 49-34A-25.4.

At its regularly scheduled meeting on February 22, 2018, the Commission considered this matter. Staff recommended approval. Having thoroughly reviewed the filings in the docket and made further inquiry of the parties at the meeting, the Commission voted unanimously to approve the TCR rates and associated tariff sheet with an effective date of March 1, 2018. It is therefore

ORDERED, that OTP's revised TCR rates are approved. It is further

ORDERED, that the above-referenced tariff sheet is approved with an effective date of March 1, 2018.
