**ORDER ASSESSING
FILING FEE

EL18-040**

On October 1, 2018, the South Dakota Public Utilities Commission (Commission) received a Petition by Northern States Power Company dba Xcel Energy (Xcel) for approval of its 2019 Infrastructure Rider Project Eligibility and Factor Update. Xcel requests approval of project eligibility for one project included in the Settlement Agreement Exhibit C not already included in the rider, project eligibility for six additional projects consistent with SDCL 49-34A-73 and the Settlement Stipulation in Docket GE17-003, the Infrastructure Rider Tracker Report and true-up for the 2018 revenue requirements, 2019 Infrastructure Rider revenue requirements of \$14.6 million, an updated Infrastructure Rider Adjustment Factor of \$0.006853, proposed revisions to the Infrastructure Rider tariff sheet, and proposed customer notice. Xcel proposes a January 1, 2019, effective date. Xcel states the average bill impact for a residential customer using 750 kWh per month will be an estimated \$5.14, a \$1.25 increase over the 2018 rate.

On October 4, 2018, the Commission electronically transmitted notice of the filing and the intervention deadline of October 19, 2018, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A-73 through 49-34A-78.

SDCL49-34A-77 requires an electric utility filing an application for a phase in rate plan to pay a filing fee to be determined by the Commission in an amount not to exceed two hundred fifty thousand dollars, \$250,000, to defray Commission expenses incident to analyzing and ruling upon this type of filing.

At its regularly scheduled meeting on October 16, 2018, the Commission considered this matter. The Commission voted unanimously to assess a filing fee as requested by Commission staff up to the statutory limit of \$250,000 to account for actual expenses incurred in review of this filing commencing from the filing date. It is therefore

ORDERED, that Xcel shall be assessed a filing fee pursuant to SDCL 49-34A-77 for actual expenses incurred by the Commission commencing from the filing date not to exceed \$250,000.
