On April 20, 2018, the South Dakota Public Utilities Commission (Commission) received an application from Otter Tail Power Company (Otter Tail or Company) for approval to increase rates for electric service in its South Dakota service territory (Application). The proposed rates may potentially affect approximately 11,700 customers in Otter Tail's South Dakota service territory. On April 26, 2018, the Commission electronically transmitted notice of the Application and the intervention deadline of June 1, 2018, to interested individuals and entities on the Commission's PUC Weekly Filings listserv. On May 16, 2018, the Commission issued an Order Suspending Operation of Proposed Rates; Order Assessing Filing Fee; Order Authorizing Consulting Contracts. On June 28, 2018, Valley Queen Cheese Factory, Inc. filed a Petition to Intervene which was granted by the Commission on July 16, 2018. On October 18, 2018, Otter Tail implemented interim rates pursuant to 49-34A-17. On February 7, 2019, the Commission issued a Scheduling Order. On March 18, 2019, the Commission issued an Amended Scheduling Order. On March 29, 2019, the parties filed a Third Stipulation for Procedural Schedule.

The Commission has jurisdiction in this matter pursuant to SDCL 1-26, 49-1A, 49-34A, and ARSD 20:10:13 and 20:10:01:15.02 through 20:10:01:15.05.

The Scheduling Order shall be amended as follows:

Post-hearing briefs April 23, 2019

Proposed Finding of Fact and Conclusions of Law (optional)

April 30, 2019

Oral Argument May 14, 2019

It is therefore
