GRANT AND CODINGTON COUNTIES	EL19-016	

On April 1, 2019, the South Dakota Public Utilities Commission (Commission) received an Application for a Wind Energy Facility Permit (Application) from Crowned Ridge Wind II, LLC (Crowned Ridge Wind or Applicant), a subsidiary of NextEra Energy Resources, LLC. Crowned Ridge Wind proposes to construct a wind energy facility to be located in Codington, Deuel and Grant Counties, South Dakota (Project). The Project would be situated within an approximately 60,996-acre project area, located east of the City of Watertown (Project Area). The Project Area is in Waverly, Kranzburg, Troy, Rome, Goodwin, and Havana Townships. The total installed capacity of the Project would be approximately 300.6 megawatts of nameplate capacity. The proposed Project includes up to 132 wind turbine generators, access roads to turbines and associated facilities, underground 34.5 kV electrical collector lines, underground fiber-optic cable, a 34.5-kV to 230-kV collection substation, up to two permanent meteorological towers, and an operations and maintenance facility. The Project would interconnect to the electric grid at the Big Stone South 230-kV Substation using the Crowned Ridge II's 5-mile 230-kV transmission line that was approved in Docket EL18-018 and the Crowned Ridge 34-mile generation tie line that was approved in Docket EL17-050. The Project is expected to be completed in 2020. Applicant has executed a purchase and sale agreement with Northern States Power Company (NSP) to sell NSP the Project upon commercial operation. Applicant estimates the total construction cost to be \$425 million.

On April 4, 2019, the Commission electronically transmitted notice of the filing and the intervention deadline of May 31, 2019, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. Party status has been granted to individuals Garry Ehlebracht, Steven Greber, Mary Greber, Richard Rall, Amy Rall and Laretta Kranz. Citing a notice issue, on May 7, 2019, Applicant filed a Request for Consent to Withdraw Application. On May 15, 2019, the Commission issued an Order Granting Request for Consent to Withdraw Application Without Prejudice and Close the Docket.

The Commission has jurisdiction in this matter pursuant to SDCL Chapters 1-26 and 49-41B and ARSD 20:10:01:02.04.

Due to the Commission's Order Granting Request for Consent to Withdraw Application without Prejudice and Close the Docket, the public input hearing scheduled for May 22, 2019, is hereby canceled. It is therefore

ORDERED, that the public input hearing scheduled for May 22, 2019, is hereby canceled.
