On October 1, 2019, the South Dakota Public Utilities Commission (Commission) received a Petition by Northern States Power Company dba Xcel Energy (Xcel) for approval of its 2020 Infrastructure Rider Project Eligibility and Factor Update. Xcel requests approval of project eligibility for one project included in the Settlement Agreement Exhibit C not already included in the rider, project eligibility for two additional wind projects consistent with SDCL 49-34A-73 and the Settlement Stipulation in Docket GE17-003, the Infrastructure Rider Tracker Report and true-up for the 2019 revenue requirements, 2020 Infrastructure Rider revenue requirements of \$19.3 million, an updated Infrastructure Rider Adjustment Factor of \$0.008873, proposed revisions to the Infrastructure Rider tariff sheet, and a proposed customer notice. Xcel proposes a January 1, 2020, effective date. Xcel states the average bill impact for a residential customer using 750 kWh per month will be an estimated \$6.65, a \$1.51 increase over the 2019 rate.

On October 3, 2019, the Commission electronically transmitted notice of the filing and the intervention deadline of October 18, 2019, to interested persons and entities on the Commission's PUC Weekly Filings electronic listserv.

The Commission has jurisdiction in this matter pursuant to SDCL 49-34A-73 through 49-34A-78.

SDCL 49-34A-77 requires an electric utility filing an application for a phase in rate plan to pay a filing fee to be determined by the Commission in an amount not to exceed \$250,000, to defray Commission expenses incident to analyzing and ruling upon this type of filing.

At its regularly scheduled meeting on October 15, 2019, the Commission considered this matter. The Commission voted unanimously to assess a filing fee up to the statutory limit of \$250,000 to account for actual expenses incurred in the review of this filing commencing from the filing date. It is therefore

ORDERED, that Xcel shall be assessed a filing fee pursuant to SDCL 49-34A-77 for actual expenses incurred by the Commission commencing from the filing date not to exceed \$250,000.
