ORDER ASSESSING  
FILING FEE

On October 31, 2019, Otter Tail Power Company (Otter Tail) filed a petition for approval of its 2020 Transmission Cost Recovery (TCR) Rider. Otter Tail's TCR rate has been adjusted to reflect the TCR revenue requirements for the next recovery period (March 2020 – February 2021). The update includes the tracker balance estimated for the end of the current recovery period so that no over- or under-recovery of TCR costs occurs. The update also includes a class allocation true-up as agreed upon in EL18-048 to help mitigate any cross-class subsidies.

On November 7, 2019, the Commission electronically transmitted notice of the filing and the intervention deadline of November 22, 2019, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv.

The Commission has jurisdiction in this matter pursuant to SDCL Chapters 1-26, 49-1A, and 49-34A, particularly SDCL 49-1A-8 and 49-34A-25.1 through 49-34A-25.4.

SDCL 49-1A-8 authorizes the Commission to require a deposit of up to \$50,000 in the Commission's Regulatory Assessment Fee Fund to defray Commission expenses incident to analyzing and ruling upon this type of filing.

At its regularly scheduled meeting on November 12, 2019, the Commission considered this matter. The Commission voted unanimously to assess a filing fee as requested by Commission staff up to the statutory limit of \$50,000 to account for actual expenses incurred in review of this filing commencing from the filing date. It is therefore

ORDERED, that Otter Tail shall be assessed a filing fee pursuant to SDCL 49-1A-8 for actual expenses incurred by the Commission commencing from the filing date not to exceed \$50,000.
