IN THE MATTER OF THE PETITION OF MIDAMERICAN ENERGY COMPANY FOR APPROVAL OF TARIFF REVISIONS

ORDER APPROVING TARIFF REVISIONS NG09-004

On June 5, 2009, the Public Utilities Commission (Commission) received an application from MidAmerican Energy Company (MidAmerican) requesting cancellation of its monthly metered transportation gas pilot project and interruptible monthly metered transportation gas pilot project tariffs (pilot tariffs) effective July 15, 2009. The availability of these pilot tariffs expired April 30, 2009, and has been replaced by a permanent monthly metered transportation service, approved by the Commission on April 21, 2009; all customers participating in the pilot programs have been transitioned to the permanent program. MidAmerican opted to retain the pilot tariffs until completion of the transition and is now requesting cancellation of the pilot tariffs. Additionally, MidAmerican is updating its table of contents to reflect the above-discussed changes. On July 23, 2009, the Commission received revised tariff sheets from MidAmerican.
