On July 28, 2016, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Corporation dba NorthWestern Energy (NorthWestern) for approval of tariff revisions to its sample forms. The purpose of this filing is to improve communication with customers by adding form letters to the natural gas tariff. NorthWestern requests an effective date of September 1, 2016.

On August 4, 2016, the Commission electronically transmitted notice of the filing and the intervention deadline of August 19, 2016, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

On August 19, 2016, NorthWestern filed its responses to Staff's data request and revised tariff pages. On August 25, 2016, NorthWestern filed additional revised tariff pages. The revised tariff sheets are as follows:

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, particularly 49-34A-4 and 49-34A-10, and ARSD 20:10:13:12 and 20:10:17:10.

At its regularly scheduled meeting on August 30, 2016, the Commission considered this matter. Commission staff recommended approval of the tariff revisions as filed on August 25, 2016, with an effective date of September 1, 2016. Finding the revisions to be just and

reasonable, the Commission voted unanimously to approve the tariff revisions effective September 1, 2016. It is therefore

ORDERED, that NorthWestern's request to revise its tariffs is hereby granted and the revisions are approved, effective for services rendered on and after September 1, 2016.
