**ORDER APPROVING
TARIFF REVISIONS**

On September 26, 2016, the South Dakota Public Utilities Commission (Commission) received a filing from MidAmerican Energy Company (MidAmerican) for approval of tariff revisions. MidAmerican proposes to add a new Producer of Renewable Gas Transportation Service to its gas tariff. The new tariff will allow producers to inject renewable gas into MidAmerican's gas distribution system for use and consumption by South Dakota gas transportation customers served by MidAmerican. MidAmerican requests an effective date of November 9, 2016. The revised tariff sheets are as follows:

On September 29, 2016, the Commission electronically transmitted notice of the filing and the intervention deadline of October 14, 2016, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On October 25, 2016, MidAmerican responded to Commission staff's data request.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapter 49-34A.

At its regularly scheduled meeting on November 8, 2016, the Commission considered this matter. Commission staff recommended approval of the tariff revisions. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the tariff revisions effective for service rendered on and after November 9, 2016. It is therefore

ORDERED, that the above-referenced tariff sheets are hereby approved effective for service on and after November 9, 2016.
