On January 10, 2017, the South Dakota Public Utilities Commission (Commission) received a filing by Montana-Dakota Utilities (MDU) for approval of tariff revisions regarding its Meter Data and Privacy Policy Tariff Rate 140. MDU requests that the Meter Data and Privacy Policy be inserted in Section 5 of its South Dakota Gas Rate Schedule designated as Rate 140 for its natural gas utility.

On January 12, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of January 27, 2017, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On January 30, 2017, MDU responded to Commission staff's data request. On February 1, 2017, MDU filed an additional tariff page for approval. MDU requested a February 10, 2017, effective date.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, and 49-34A-12, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on February 10, 2017, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with a February 10, 2017, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective February 10, 2017. It is therefore

ORDERED, that the above-referenced tariff sheets are approved, effective February 10, 2017.
