ORDER APPROVING TARIFF REVISIONS

On June 7, 2017, the South Dakota Public Utilities Commission (Commission) received an application from Montana-Dakota Utilities Co. (MDU) for approval of its revised Transportation Service Rates 81 and 82 and Gas Transportation Agreement. MDU proposes the revisions to remove duplication of provisions in the Tariff and Agreement, simplify the balancing provision, and update the Tariff to reflect current practices and procedures of MDU. On June 27, 2017, MDU responded to Staff's data request. On August 30, 2017, MDU filed revised tariff pages.

At its regularly scheduled meeting on September 12, 2017, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with a November 1, 2017, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the tariff revisions. It is therefore

ORDERED, that MDU's revised tariff as described above is approved effective November 1, 2017.
