On January 29, 2018, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Corporation dba NorthWestern Energy (NorthWestern) requesting approval for a contract with deviations with NuGen Energy, LLC (NuGen). NuGen has reached the expiration date of its initial contract. NorthWestern desires to provide this customer with continuing natural gas service and has negotiated a new contract with deviations. NorthWestern states the new rate will allow NorthWestern to maintain NuGen as a customer, which will benefit not only NuGen but also NorthWestern and its natural gas customers through recovery of administrative and general costs and common costs from this customer. NorthWestern requests an effective date for the tariff revisions of March 1, 2018. The revised tariff sheet is as follows:

Canceling 10th Revised Sheet No. 2

On February 1, 2018, the Commission electronically transmitted notice of the filing and the intervention deadline of February 16, 2018, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A, specifically 49-34A-6, 49-34A-8, 49-38A-8, 49-34A-10, and 49-34A-11.

At its regular meeting on February 22, 2018, the Commission considered this matter. Commission staff recommended approval. Finding that NorthWestern's request for approval of a contract with deviations with NuGen and the associated tariff sheet is just and reasonable, the Commission voted unanimously to grant NorthWestern's request for approval of a contract with deviations and to approve the associated tariff sheet with an effective date of March 1, 2018. It is therefore

ORDERED, that NorthWestern's request seeking approval of a contract with deviations with NuGen is hereby granted with an effective date of March 1, 2018. It is further

ORDERED, that the revisions of the above-referenced tariff sheet to reflect the contract with deviations with NuGen is approved, effective March 1, 2018.
