On June 9, 1997, the Public Utilities Commission (Commission) received a request for designation as an eligible telecommunications carrier (ETC) from Vivian Telephone Company d.b.a. Golden West Communications, Inc. (Vivian). Vivian requested designation as an eligible telecommunications carrier within the local exchange areas that constitute its service area.

The Commission electronically transmitted notice of the filing and the intervention deadline to interested individuals and entities. No person or entity filed to intervene. By order dated November 7, 1997, the Commission set the hearing for this matter for 1:30 p.m. on November 19, 1997, in Room 412, State Capitol, Pierre, South Dakota.

The hearing was held as scheduled. At the hearing, the Commission granted Vivian a one year waiver of the requirement to provide toll control service within its service area. At its December 11, 1997, meeting, the Commission granted ETC designation to Vivian and designated its study area as its service area.

Based on the evidence of record, the Commission enters the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT**

I

On June 9, 1997, the Commission received a request for designation as an ETC from Vivian. Vivian requested designation as an ETC within the local exchange areas that constitute its service area. Vivian serves the following exchanges: Avon, SD (286); Bonesteel, SD (654); South Bonesteel, NE (653); Burke, SD (775); South Burke, NE (774); Clearfield, SD (557); Custer, SD (673); Freeman, SD (925); Gregory, SD (835); South Gregory, NE (974); Lesterville, SD (364); Marion, SD (648); Menno, SD (387); Mission, SD (856); Murdo, SD (669); Reliance, SD (473); Rosebud, SD (747); Scotland, SD (583); Springfield, SD (369); Vivian, SD (683); Winner, SD (842); and Witten, SD (879). II

Pursuant to 47 U.S.C. § 214(e)(2), the Commission is required to designate a common carrier that meets the requirements of section 214(e)(1) as an ETC for a service area designated by the Commission.

III

Pursuant to 47 U.S.C. § 214(e)(1), a common carrier that is designated as an ETC is eligible to receive universal service support and shall, throughout its service area, offer the services that are supported by federal universal service support mechanisms either using its own facilities or a combination of its own facilities and resale of another carrier's services. The carrier must also advertise the availability of such services and the rates for the services using media of general distribution.

IV

The Federal Communications Commission (FCC) has designated the following services or functionalities as those supported by federal universal service support mechanisms: (1) voice grade access to the public switched network; (2) local usage; (3) dual tone multi-frequency signaling or its functional equal; (4) single party service or its functional equivalent; (5) access to emergency services; (6) access to operator services; (7) access to interexchange service; (8) access to directory assistance; and (9) toll limitation for qualifying low-income consumers. 47 C.F.R. § 54.101(a).

V

As part of its obligations as an ETC, an ETC is required to make available Lifeline and Link Up services to qualifying low-income consumers. 47 C.F.R. § 54.405; 47 C.F.R. § 54.411.

VI

Vivian offers voice grade access to the public switched network to all consumers throughout its service area. Exhibit 1.

VII

Vivian offers local exchange service including an amount of local usage free of per minute charges to all consumers throughout its service area. Id.

VIII

Vivian offers dual tone multi-frequency signaling to all consumers throughout its service area. Id.

IX

Vivian offers single party service to all consumers throughout its service area. Exhibit 2.

X

Vivian offers access to emergency services to all consumers throughout its service area. Exhibit 1.

XI

Vivian offers access to operator services to all consumers throughout its service area. Id.

XII

Vivian offers access to interexchange services to all consumers throughout its service area. Id.

XIII

Vivian offers access to directory assistance to all consumers throughout its service area. Id.

XIV

One of the services required to be provided by an ETC to qualifying low-income consumers is toll limitation. 47 C.F.R. § 54.101(a)(9). Toll limitation consists of both toll blocking and toll control. 47 C.F.R. § 54.400(d). Toll control is a service that allows consumers to specify a certain amount of toll usage that may be incurred per month or per billing cycle. 47 C.F.R. § 54.400(c). Toll blocking is a service that lets consumers elect not to allow the completion of outgoing toll calls. 47 C.F.R. § 54.400(b).

XV

Vivian offers toll blocking to all consumers throughout its service area. Exhibit 1.

XVI

Vivian does not currently offer toll control. Id. In order for Vivian to provide toll control, additional usage tracking and storage capabilities will have to be installed in its local switching equipment. Vivian is attempting to determine whether the necessary software has been developed and when it might become available. Id.

XVII

Vivian stated that it is faced with exceptional circumstances concerning its ability to make toll control service available and requested a one year waiver from the requirement to provide such service. Id. Prior to the end of the one year period, Vivian will report back to the Commission with specific information indicating when the network upgrades can be made in order to provide toll control. Id.

XVIII

With respect to the obligation to advertise the availability of services supported by the federal universal service support mechanism and the charges for those services using media of general distribution, Vivian stated that it advertises the availability of its local exchange services in media of general distribution throughout its service area. However, Vivian has not generally advertised the prices for these services. Id. Vivian stated its intention to comply with any advertising standards developed by the Commission. Id.

XIX

Vivian offers Lifeline and Link Up service discounts in some of its exchanges. Exhibit 2. Vivian will offer the Lifeline and Link Up service discounts in all of its service area beginning January 1, 1998, in accordance with 47 C.F.R. §§ 54.400 to 54.417, inclusive, and any Commission imposed requirements. Exhibit 2.

XX

The Commission finds that Vivian currently provides and will continue to provide the following services or functionalities throughout its service area: (1) voice grade access to the public switched network; (2) local usage; (3) dual tone multi-frequency signaling; (4) single-party service; (5) access to emergency services; (6) access to operator services; (7) access to interexchange service; (8) access to directory assistance; and (9) toll blocking for qualifying low-income consumers.

XXI

The Commission finds that pursuant to 47 C.F.R. § 54.101(c) it will grant Vivian a waiver of the requirement to offer toll control services until December 31, 1998. The Commission finds that exceptional circumstances prevent Vivian from providing toll control at this time due to the difficulty in obtaining the necessary software upgrades to provide the service.

XXII

The Commission finds that Vivian intends to provide Lifeline and Link Up programs to qualifying customers throughout its service area consistent with state and federal rules and orders.

XXIII

The Commission finds that Vivian shall advertise the availability of the services supported by the federal universal service support mechanism and the charges therefor throughout its service area using media of general distribution once each year. The Commission further finds that if the rate for any of the services supported by the federal universal service support mechanism changes, the new rate must be advertised using media of general distribution.

XXIV

Pursuant to 47 U.S.C. § 214(e)(5), the Commission designates Vivian's current study area as its service area.

**CONCLUSIONS OF LAW**

I

The Commission has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-31, and 47 U.S.C. § 214.

II

Pursuant to 47 U.S.C. § 214(e)(2), the Commission is required to designate a common carrier that meets the requirements of section 214(e)(1) as an ETC for a service area designated by the Commission.

III

Pursuant to 47 U.S.C. § 214(e)(1), a common carrier that is designated as an ETC is eligible to receive universal service support and shall, throughout its service area, offer the services that are supported by federal universal service support mechanisms either using its own facilities or a combination of its own facilities and resale of another carrier's services. The carrier must also advertise the availability of such services and the rates for the services using media of general distribution.

IV

The FCC has designated the following services or functionalities as those supported by federal universal service support mechanisms: (1) voice grade access to the public switched network; (2) local usage; (3) dual tone multi-frequency signaling or its functional equal; (4) single party service or its functional equivalent; (5) access to emergency services; (6) access to operator

services; (7) access to interexchange service; (8) access to directory assistance; and (9) toll limitation for qualifying low-income consumers. 47 C.F.R. § 54.101(a).

V

As part of its obligations as an ETC, an ETC is required to make available Lifeline and Link Up services to qualifying low-income consumers. 47 C.F.R. § 54.405; 47 C.F.R. § 54.411.

VI

Vivian has met the requirements of 47 C.F.R. § 54.101(a) with the exception of the ability to offer toll control. Pursuant to 47 C.F.R. § 54.101(c), the Commission concludes that Vivian has demonstrated exceptional circumstances that justify granting it a waiver of the requirement to offer toll control services until December 31, 1998.

VII

Vivian shall provide Lifeline and Link Up programs to qualifying customers throughout its service area consistent with state and federal rules and orders.

VIII

Vivian shall advertise the availability of the services supported by the federal universal service support mechanism and the charges therefor using media of general distribution once each year. If the rate for any of the services supported by the federal universal service support mechanism changes, the new rate shall be advertised using media of general distribution.

IX

Pursuant to 47 U.S.C. § 214(e)(5), the Commission designates Vivian's current study area as its service area.

X

The Commission designates Vivian as an eligible telecommunications carrier for its service area.

It is therefore

ORDERED, that Vivian's current study area is designated as its service area; and it is

FURTHER ORDERED, that Vivian shall be granted a waiver of the requirement to offer toll control services until December 31, 1998; and it is

FURTHER ORDERED, that Vivian shall follow the advertising requirements listed above; and it is

FURTHER ORDERED, that Vivian is designated as an eligible telecommunications carrier for its service area.

NOTICE OF ENTRY OF ORDER

PLEASE TAKE NOTICE that this Order was duly entered on the 17<sup>th</sup> day of December, 1997. Pursuant to SDCL 1-26-32, this Order will take effect 10 days after the date of receipt or failure to accept delivery of the decision by the parties.
