On December 24, 1997, the Public Utilities Commission (Commission) received a complaint from Jerome Jacobs, Pierre, South Dakota, against U S West Communications, Inc. (U S West) regarding having an extra line installed. Mr. Jacobs states that "he would like to have an extra line for present and future development. U S WEST said that I would have to pay for this line and service at a very high cost." Mr. Jacobs is requesting that U S WEST pay for this installation.

Pursuant to ARSD 20:10:01:08.01 and 20:10:01:09, if a complaint cannot be settled without formal action, the Commission shall determine if the complaint shows probable cause of an unlawful or unreasonable act, rate, practice or omission to go forward with the complaint.

On December 30, 1997, at its duly noticed meeting, the Commission deferred the complaint. On April 22, 1998, the matter was again deferred. At its regularly scheduled July 23, 1998, meeting, the matter was again deferred as Commission Staff was unable to contact Mr. Jacobs to confirm that this matter had been satisfactorily resolved. Commission Staff sent Mr. Jacobs a certified letter on August 5, 1998, requesting his confirmation that the matter had been satisfactorily resolved. Mr. Jacobs never responded to the letter. On August 18, 1998, at the Commission's regularly scheduled meeting, U S WEST's representative stated that it had installed the line requested by Mr. Jacobs. Commission Staff recommended dismissing the complaint and closing the docket.

The Commission has jurisdiction over this matter pursuant to SDCL 49-13-1, 49-13-4, 49-31-7, 49-31-7.1, and ARSD 20:10:01:07.01 and 20:10:01:08.01. The Commission unanimously voted to dismiss the complaint and to close the docket. It is therefore

ORDERED, that this complaint be dismissed and the docket closed.
