ORDER GRANTING  
CERTIFICATE OF  
AUTHORITY

On April 30, 1999, the Public Utilities Commission (Commission), in accordance with SDCL 49-31-3 and ARSD 20:10:24:02, received an application for a certificate of authority from NET-tel Corporation d/b/a NET-tel Communications Corporation (FL) (NET-tel).

NET-tel proposes to offer outbound presubscribe and casual calling service, toll free inbound service and travel card service. A proposed tariff was filed by NET-tel. The Commission has classified long distance service as fully competitive.

On May 6, 1999, the Commission electronically transmitted notice of the filing and the intervention deadline of May 21, 1999, to interested individuals and entities. No petitions to intervene or comments were filed and at its July 13, 1999, meeting, the Commission considered NET-tel's request for a certificate of authority. Commission Staff recommended granting a certificate of authority, subject to the condition that NET-tel not offer a prepaid calling card or require deposits or advance payments without prior approval of the Commission.

The Commission finds that it has jurisdiction over this matter pursuant to Chapter 49-31, specifically 49-31-3 and ARSD 20:10:24:02 and 20:10:24:03. The Commission finds that NET-tel has met the legal requirements established for the granting of a certificate of authority. NET-tel has, in accordance with SDCL 49-31-3, demonstrated sufficient technical, financial and managerial capabilities to offer telecommunications services in South Dakota. The Commission approves NET-tel's application for a certificate of authority, subject to the condition that NET-tel not offer a prepaid calling card or require deposits or advance payments without prior approval of the Commission. As the Commission's final decision in this matter, it is therefore

ORDERED, that NET-tel's application for a certificate of authority is hereby granted, subject to the condition that NET-tel not offer a prepaid calling card or require deposits or advance payments without prior approval of the Commission. It is

FURTHER ORDERED, that NET-tel shall file informational copies of tariff changes with the Commission as the changes occur.
