On August 13, 2001, the South Dakota Public Utilities Commission (Commission) received a filing from the Local Exchange Carriers Association (LECA) for approval of revisions to its LECA Tariff No. 1. The purpose of the filing is to reflect an additional exchange participating in the tariff and the consolidation of several subsidiary companies into the parent company.

On August 16, 2001, the Commission electronically transmitted notice of the filing and the intervention deadline of August 31, 2001, to interested individuals and entities. No parties sought intervention.
