On June 28, 2006, the Pubic Utilities Commission (Commission) received a petition from Roberts County Telephone Cooperative Association (Roberts County) requesting the Commission grant an extension of the six month filing deadline for its 2006 intrastate switched access cost study.

On June 29, 2006, the Commission electronically transmitted notice of the filing and the intervention deadline of July 14, 2006, to interested individuals and entities. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL 1-26-17.1, 49-1A-9, 49-31-12.6, 49-31-18, 49-31-19 and ARSD 20:10:01:15.02, 20:10:01:15.05, 20:10:27:07 and 20:10:27:08. On August 8, 2006, at its regularly scheduled meeting, the Commission found good cause to grant the requested extension until December 31, 2006, and unanimously voted to grant the requested extension until December 31, 2006.

On November 8, 2006, the Commission received a Settlement Stipulation signed by the parties.

At its regularly scheduled meeting of November 14, 2006, the Commission considered whether to reopen this docket, approve the Settlement Stipulation and dismiss and close this docket. The Commission voted unanimously to reopen this docket, to approve the Settlement Stipulation and dismiss and close the docket. It is therefore

ORDERED, that this docket is hereby reopened, the Settlement Stipulation is approved and the docket is dismissed and closed.
