On December 18, 2006, the Public Utilities Commission (Commission) received a request from 1-800-Reconex, Inc. d/b/a USTel (Reconex) for approval of an extension of its exemption from the requirement to develop intrastate switched access rates based on company specific costs. On January 5, 2007, the Commission received an amended request from Reconex. Additionally, Reconex requested a waiver of the use of the formula in ARSD 20:10:27:12 and a waiver of the three year filing requirement in ARSD 20:10:27:07.

On January 23, 2007, the Commission considered Reconex's request for approval of a continuation of its exemption from establishing switched access rates based on company specific costs and the request for waivers of ARSD 20:10:27:07 and ARSD 20:10:27:12. The Commission has jurisdiction over this matter pursuant to SDCL 49-31-18, 49-31-19, and ARSD 20:10:27. The Commission voted to grant an extension of its exemption and approve the waivers of ARSD 20:10:27:07 and ARSD 20:10:27:12. It is therefore

ORDERED, that Reconex is approved for an extension of its exemption from establishing company specific cost-based switched access rates so long as Reconex's intrastate switched access rate is equal to or less than that of the Qwest intrastate switched access rate or until the Commission shall otherwise order. It is further

ORDERED, that the waiver of ARSD 20:10:27:12 is granted.
