On May 4, 2011, the Public Utilities Commission (Commission) received a filing from 360networks(USA) inc. (360networks) for changes to its switched access tariff sheets 2, 51, 52 and 54, which address changes to its switched access tariff and reintroduces a Toll Free Data Base Access Service. 360networks also requests a waiver of ARSD 20:10:27:07 and requests an effective date of June 6, 2011. On May 5, 2011, the Commission electronically transmitted notice of the filing and the intervention deadline of May 20, 2011, to interested individuals and entities. No parties sought intervention.

The following tariff pages were filed with regard to its Switched Exchange Access Telecommunications Services Tariff No. 2, 51, 52, and 54:

At its regularly scheduled meeting of June 14, 2011, the Commission considered this matter.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31. The Commission voted unanimously to approve the above revisions to 360networks's Switched Exchange Access Telecommunications Services Tariff No. 2, 51, 52, and 54 and to grant a waiver of ARSD 20:10:27:07.

It is therefore

**ORDERED**, that the Commission approves the above referenced revisions to 360networks' Switched Exchange Access Telecommunications Services Tariff No. 2, 51, 52, and 54 effective as of June 6, 2011.

It is further

**ORDERED**, that the Request for Waiver of ARSD 20:10:27:07 is hereby granted.
