On May 17, 2011, the Public Utilities Commission (Commission) received a petition by Inmate Calling Solutions, LLC d/b/a ICSolutions requesting an amendment to its certificate of authority (COA). In TC07-090, ICSolutions was granted a COA subject to the continuous maintenance of a letter of credit. ICSolutions is requesting that it be permitted to amend its COA such that it will have an Indemnity Bond in the amount of \$25,000 in lieu of an irrevocable letter of credit and requesting an effective date of June 1, 2011. On May 19, 2011, the Commission electronically transmitted notice of the filing and the intervention deadline of June 3, 2011, to interested individuals and entities. No petitions to intervene were filed.

At its June 14, 2011, meeting, the Commission considered whether to ICSolution's application for an amended certificate of authority. Commission Staff recommended its approval.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapter 49-31, specifically 49-31-3 and ARSD 20:10:24:02 and 20:10:24:03. The Commission finds that ICSolutions has met the legal requirements established for the granting of a certificate of authority. ICSolutions has, in accordance with SDCL 49-31-3, demonstrated sufficient technical, financial, and managerial capabilities to offer telecommunications services in South Dakota.

The Commission unanimously voted to approve ICSolution's application for an amended certificate of authority, subject to a continuous \$25,000 surety bond in lieu of an irrevocable letter of credit.

It is therefore

ORDERED, that ICSolution's application for an amended certificate of authority to provide interexchange telecommunications services is hereby granted, subject to a continuous \$25,000 surety bond in lieu of an irrevocable letter of credit and with an effective date of June 29<sup>th</sup> 2011.
