**ORDER APPROVING TARIFF  
REVISIONS**

On March 14, 2012, Knology of the Plains, Inc. (Knology) filed for approval of revisions to its South Dakota Access Tariff No. 1. with the Public Utilities Commission (Commission). This filing reflects the addition of language for the implementation of the intercarrier compensation regime for certain VoIP-PSTN traffic as mandated in the Federal Communications Commission's Report and Order and Further Notice of Proposed Rulemaking in WC Docket No. 10-90, etc., FCC No. 11-161 (released November 18, 2011) "FCC Order." On April 18, 2012, Knology filed its responses to staff's first and second data requests, and on May 1, 2012, the Commission received revisions to section 2 incorporating additional VoIP-PSTN clarification language. Knology requests an effective date for this revision of March 15, 2012.
